# COMMENTS FROM THE AUDIENCE

• Dave Cooper: Congrats to the village for the piece of equipment to mow over the guard rail. He has reached out to ODOT in passed- was told its not their job. Asked about the 52 potholes. Per Councilperson Feldkamp US 52 is a Federal Highway. Heard that mowing on US 52 was \$15k. Village use to borrow a tractor but ended up purchasing a used one. We do get revenue from the State, gas tax and license plates. Local Government Fund was cut. Councilperson Allen thanked him for the compliment.

# **ADMINISTRATIVE REPORTS:**

# Village Administrator Bob Lindhorst

- Public Restrooms have been de-winterized and are now open, hours of operation 6:30am to 11:00pm daily. Street
  department will open in the morning Monday through Friday and the police Department will close during the week and
  open and close on the weekend.
- The water fountains at the dog Park are now operational.
- The Power Initiative Grant Application was submitted Wednesday April 19th to the Appalachian Regional Commission (ARC) for \$50K. In short it is a planning grant to recover from the closing of the Beckjord Power Station and the associated jobs, and tax revenue lost. The \$50,000 ARC POWER grant will be used to evaluate a possible Solar/Green Hydrogen facility on the Beckjord property and the associated benefits to the village.

- Meant with Dave Rose and Gary Blandon from Skippers and representing the village, was Councilperson Ryan Woodruff, Councilperson Richard Feldkamp, Fire/EMS Chief Tim Feldkamp, Police Chief Eric Williams, and myself. Dave Rose requested the meeting because of the letter that was sent on March 28, which stated the village did not have a current copy of their Liability Insurance and the village was also missing the operational plans for 2021 and 2022. Skippers did drop full coverage insurance which is concerning. The letter also stated that the current state of the licensed area is not satisfactory to the village. They did supply the information requested. After an hour of conversations what came out was, they did install (2) head cables, they are planning to get the (2) new spud poles in over next couple of weeks, will secure the door to head boat to hinder access, and hope to have the boat back in the water in 4 weeks.
- The ZBA committee held a meeting this past Saturday the 22nd regarding Rodrick Crousey, owner of New Richmond Distilleries, requesting a zoning ordinance variance for the property located on Washington Street, Parcel #260910.001, about putting an accessory structure on the aforementioned property when there is no primary structure located on the site at this time. The ZBA granted the variance. Minutes attached. The plans are to have Tasting/Sampling and Food Trucks, strictly retail. There was discussion as to this being the location of the first distillery in New Richmond.
- Councilperson Allen commended Bob with the Dumpster company. It was determined that the full dumpsters with household items were items left over from the previous owner. All dumpsters are staging for construction companies.
   Bob will continue to work with the new owner.

# Police Chief Eric Williams

- 17 Traffic Stops, 2 Criminal Arrests, 15 Traffic Arrests, 7 speed and 8 other.
- Was able to secure 8 Tasers from Union Township
- Shout out to Sargent Jason Mallott and Officer Chris Beckman and Chris Pairin in regard to a gun theft and juveniles. Several arrests were made.
- Introduced Clermont County Sheriff Steve Leahy, Chief Paul Broxterman Pierce Twp and Clermont County Prosecutor Mark Tekulve. They will support New Richmond and they are committed to the village. We all work well together. Mr. Tekulve noted we made a better choice with hiring Police Chief Williams.

### Ryan Woodruff -

- The Clarks: Nothing has been done on their property. They are in violation.
- Jim Serger: He was hoping Jim would be at the meeting this evening to thank him. He is not a village resident,
- Dumpster Business on Front Street This property was sold by Andy Moran to a dumpster staging for construction, would take them to job sites, fill dumpsters, then take to Rumpke, then bring them to the site to have ready for next day. They put a 6–8-foot fence up. We could not find any regulations to say no to it going in next to El Barrill. Received a picture from a citizen sitting on patio which looks like household garbage and mattress. It seems it's not being used how they told Bob it was going to use. Councilperson Allen asked why they can't put on the other side. Planning Commission is looking at zoning and has not been modified recently. Not sure if we have legal recourse. This should have been dealt with upfront, not the new owners. Sympathetic with El Barrill at this point. Might need to discuss with Scott as to what can be done. Christine McAdams asked if there in place here at Village Hall to pick up packet for new businesses-they need to, show us a business plan. Can work side by side with business association. Kelley has been working on fee schedule comparing them to other municipalities, just to stay consistent. Discussed our staff we do not have a well-developed staff. City of Milford has every new business come into office and fill out packet. We should do the same. Councilperson Feldkamp asked if the dumpster is empty would it be a fire hazard. Fire Chief Feldkamp stated yes.
- Flood Gage Sign at Haussermann: The sign is broken and needs to be replaced. We need to acknowledge the 1937 Flood on the gage as its history.
- Inquired about signage facing the river "welcome to New Richmond", or something similar. Councilperson Tharpe will look into this as he works for a sign company.
