New Richmond Village Council met in Council Chambers, 2nd floor at 102 Willow Street, New Richmond Ohio, in regular session on Tuesday, June 13, 2023, at 7:00 p.m.

COMMUNICATIONS:

Amanda Davidson: Asked permission to do volunteer work at Green mound Cemetery. She would like to take care of headstones as she has family members buried there. She was on Council a few years ago but stepped down for health reasons but would like to be involved in this project. She has been watching videos and reading up on the protocol and any questions she may have, Robin Brewer at Washington Township is a good person to talk to. She also brought the kit to share with Council. Councilperson Woodruff confirmed that she was actually doing it the right way. Councilperson Feldkamp apologized for not recognizing her. Vice Mayor suggested she connect with Bob Lindhorst.

Sabrina Schnarrenberg: Came to Council to answer any questions about Freedom Fest and the liquor license. It was decided that we would wait till Christine McAdams is back in town as she is the Chair of event and signed the application. It was also noted that the cost for security will be \$7,500.

Gary Blanton: Came to discuss setting up a booth at the top of the hill at Skippers and a House Bill 669 that would allow him to sell during a festival. Bob Lindhorst will reach out to our Solicitor Scott Sollmann for clarification. Police Chief Williams noted that if DORA was open at events, we would need more police presence. The VFW would like Skippers to have a booth at top of hill. He would need a letter signed by Village.

Councilperson Woodruff confirmed the responsible party is Christine McAdams. She is liable and created a new 501c. He also suggested Scott Sollmann look into this. There are questions – between F Permits and DORA. Appreciates the VFW for kicking in and helping. The committee was hoping DORA would remain open per Sabrina. Will not vote on anything until Christine returns from vacation. Councilperson Allen and Feldkamp thought DORA was suspended during legacy events. Gary will even charge an extra \$1 and donate back to Freedom Fest. Councilperson Feldkamp asked Chief Police if he had concerns about the additional area if a DORA event. The village will not pick up tab for the additional officers. The fee for security would be roughly \$7,500. If Skippers gets approved for the House Bill, he would like it noted to be for the season.

Section 402: Certification of Eligibility

Current

Individuals who have immediate family member who is an elected Village officials are not eligible for employment by the Village of New Richmond, Ohio. In addition, an individual who has a family member currently employed as a supervisor or department head is not eligible for employment within the department in which the employee is employed as a supervisor or department head. This will not require the removal of an existing employee, whose family member is elected to office or who becomes a department head after an employee is hired. The Chief Personnel Administrator shall make a recommendation to the Personnel and Finance Committee who shall then consider this recommendation of the Chief Personnel Administrator and if they agree with the recommendation recommend to full council the individual for employment.

Proposed Change

An individual who has a family member currently employed as a supervisor or department head is not eligible for employment within the department in which the employee is employed as a supervisor or department head. This will not require the removal of an existing employee, whose family member is elected to office or who becomes a department head after an employee is hired.
