There were discussions in the normal four broad areas: Finance, Village Administration, Police Department, and the Fire & EMS Department.

Finance - Fiscal Officer Joel Gilpin

- 1. Interest earned from StarOhio for May was \$4, 930.09
- 2. RITA will be implementing the Subpoena Program again for Non-filing Taxpayers
- 3. We're still waiting on Duke Energy and their contractors to finish their estimates for replacing the streetlights with LED fixtures. Joel has also asked them about doing Rose Vesper Park. We have the funds to help pay for the park from the county park district.
- 4. To put a tax levy on the November 2023 ballot we first need a Resolution of Necessity passed and filed. The County will give us estimates of taxes produced. Then we must file a Resolution to Proceed.
- 5. The Tax Budget is due July 14th to the county auditor A public Tax Budget Meeting is scheduled for July 11 2023 at 6:45 p.m.
- 6. Loan payments are due July 1st and 3rd totaling \$81,494.33
- 7. There was more discussion about the market adjustments to be made. Joel provided the attached market adjustments to be made.

Motion: Motion to accept the market adjustment recommendations presented to Council from Chief Tim Feldkamp, Chief Eric Williams, and from Interim Administrator, Bob Lindhorst. These changes will be effective the first pay period following the initial motion, which is June 2, 2023

Motion: Motion to pay the bills.

There has been discussion about changing or removing the nepotism language in the Village of New Richmond Personnel Policy. After speaking with our Solicitor, Scott Solman, I'm recommending we change the wording per the attached document.

Motion: I make a motion to change the Village of New Richmond Personnel Policy, Section 402: Certification of Eligibility to read:

An individual who has a family member currently employed as a supervisor or department head is not eligible for employment within the department in which the employee is employed as a supervisor or department head. This will not require the removal of an existing employee, whose family member is elected to office or who becomes a department head after an employee is hired.

Village Administration – Interim Village Administrator Bob Lindhorst

- 1. Discussed his proposed market adjustments.

Police Department - Police Chief, Eric Williams

Chief Williams had nothing to report at this time.

Fire/EMS Department - Fire/EMS Chief Tim Feldkamp

1. Hire Robin Taylor, Andrew Royalty, and Lucas Kroener as part-time Firefighter/EMT's at a rate of \$16.10 an hour starting June 14, 203. They will all serve a one-year probation and pay into social security.

2. Accept the resignation of Miranda Sims effective May 19, 2023. She does not leave in good standing.

Motion: Motion to accept the resignation of Miranda Sims effective May 19, 2023.

There was additional discussion again about the need to put a tax levy on the November ballot. The Committee has agreed to have an additional Personnel & Finance Committee Meeting on Monday, June 26,20234:30-5:30 to discuss planning and next steps.

Section 402: Certification of Eligibility

Current

Individuals who have an immediate family member who is an elected Village official are not eligible for employment by the Village of New Richmond, Ohio. In addition, an individual who has a family member currently employed as a supervisor or department head is not eligible for employment within the department in which the employee is employed as a supervisor or department head. This will not require the removal of an existing employee, whose family member is elected to office or who becomes a department head after an employee is hired. The Chief Personnel Administrator shall make a recommendation to the Personnel and Finance Committee who shall then consider the recommendation of the Chief Personnel Administrator and if they agree with the recommendation recommend to full council the individual for employment.

Proposed Change

An individual who has a family member currently employed as a supervisor or department head is not eligible for employment within the department in which the employee is employed as a supervisor or department head. This will not require the removal of an existing employee, whose family member is elected to office or who becomes a department head after an employee is hired.
