Ron Henderson/River Days Committee: Came forward today requesting DORA to be shut down for River Days. # **Village Administrator Bob Lindhorst:**

Finished up mapping for water and wastewater lines running under US 52 for 143 Engineers regarding the Round-About Project.

Stormwater issues over the last (2) storm events

- 1. Old US 52 by River Valley Blvd.
- 2. Around 706 & 821 Greenmound.
- 3. Columbia & Quarry.
- 4. Caroline and Plenty.
- 5. Front St by Plum Street Park (Dobbins).
- 6. 202 Compass.

Reached out for pricing to camera the mention areas to determine the possible issue for the slow drainage estimated cost for one day services is around \$2850. Level 2 EVCharging Grant from the Ohio EPA for \$15K, goes back to June 2021. I have a quote from EV United with items listed below:

Working with Emily Lescott OEPA, and Environment Engineering for New Richmond's WRSLA PFAS evaluation treatment planning project. The village will be receiving \$50K in principal forgiveness, so the only out of pocket cost is the application fee of \$175. I don't believe we need a resolution.

Same topic, I had a go-to meeting with Norm Collins, Jonathan Deters and Brandon Taylor on information they requested for the complaint filed by the Village. Should have the information to them by the end of the week.

Councilperson Feldkamp asked about the High Street house. Police Chief Williams and Fire Chief Feldkamp visited the property. Homeowner stated that people were living in there, with electric water and sewer hooked up. She was told that it is not permitted, and she unhooked it. The campers are waiting for house to be built. Per the Permit, it says 2 years to complete. That shouldn't be the case. Scott Sollmann noted they do not have 2 years to fix it, just 2 years to get up. It's a violation of zoning and we could take legal action. As far as Clark's property, we have haven't heard anything.

## **Police Chief Eric Williams:**

- 40 Total Stops, 17 for Speed, 3 for Criminal, 20 Other Traffic
- Be mindful of Events with DORA and F Permits. That will put a lot on the Police
  Officers due to having to set up boundaries. Scott Sollmann will check in to this.
  Can we get clarification of DORA and F Permits, F Permits sets up boundaries.
  ED Over serving and underage consumption. State is not concerned about
  DORA. Councilperson Prues noted that other Municipalities go events with DORA
  and there have been no issues.
