Other

- Conducted a preliminary walk through of Ashburn Woods Phase 1 with the developer, HPA Developer Group, Choice One Engineering (who represents the Village), and myself. Issues noted:
 - For easier access, water meters and curb valves need to be raised level to the lawn.
 - Several feet of curb in many areas need to be replaced due to cracks and chunks on the edges.
 - Several sidewalk blocks need to be replaced due to cracks.
- Once the Ohio Environmental Protection Agency (OEPA) approves the Permit-to-Install (PTI), Ashburn Woods Phase 2 work can begin. The anticipated start date is mid-to-late August.

Planning & Zoning Monthly Report - Bob Lindhorst (continued):

 Phase 1 of Liberty Landing is complete. The Request for Qualifications (RFQ) for Liberty Landing Phase 2 legal notice was posted in the Clermont Sun for three (3) consecutive weeks, starting on July 20th and ending today, August 3rd. The grant amount for phase 2 is \$300,000.00.

Additional business:

- Council Member Woodruff will ask Council to consider extending the moratorium on drug rehab facilities, to allow for additional work on a legislative draft. He plans to discuss the draft in more depth at the September Planning Commission meeting.
- Clerk Kelley Snider sent a proposal via email regarding the allowance of unlimited yard sale permits with several caveats i.e., cannot take place during legacy events, run longer than 3 or 4 days, and must be packed up/removed from yard upon expiration of the permit. The majority felt it was a good idea; further discussion ensued.
- Mayor Ewing mentioned the numerous vacant properties in our Village, especially
 in the business district. Several ideas were discussed on how to address the
 vacancies. Council Member Woodruff stated he would like to reintroduce this
 topic to Council.
- Council Member Woodruff mentioned that Ohio Revised Code says the Planning Commission oversees the ad hoc Landmark Committee. Most agreed the Planning Commission should be the "one-stop shop" for historic property owners to come to for requests and approvals.
- All agreed that a review of the current zoning maps and overlays were a priority.
- Mayor Ewing approved Theresa's request to become an alternate member and would like Bryan Bailey to take her place. If not already approved by Council, Mayor Ewing will present to Council at the next meeting.

With no more to discuss, Councilman Woodruff made a motion to adjourn. Theresa seconded.
