Sale of Village Property:

Resolution 2017-04 authorizing the advertisement for bids for the sale of a parcel formed from Plum and Water Streets is introduced tonight for first reading. Establishing a parcel number, deed and bid documents are anticipated to be ready by second reading. According to the solicitor Resolution 2017-04 requires a 2/3 vote to pass.

Group Homes:

Companies have been establishing group homes for various special needs individuals in residential neighborhoods in Clermont County. Under New Richmond Zoning Code establishing such group homes in properties zoned residential is considered a change of use and would require a Board of Zoning Appeals hearing and BZA approval. Potential issues with group homes include parking problems, safety concerns and decline in property values in residential neighborhoods. There was a brief discussion regarding Sterling Homes and Greg is going to contact Fischer Homes to extend our welcome as a community.
