# Bob Lees, 1515 Indian Ridge:

- Is your community/organization willing to contribute financially to this process?
- Where in your community is your best opportunity that you would like studied?

## Greg Roberts, Village Administrator:

#### Nuisance Properties:

Legislation is being brought forth tonight regarding two nuisance properties. 619 Market Street and a dangerous tree at 718 Washington Street. Two professional arborist have declared the tree as dangerous.

# Knothole License:

Knothole has met some difficulties in meeting obligations under the current license agreement. Seeking council advice on the issue. (Council waived 2017 lease payment) Duke Energy Powerline Work:

Duke is working on removing some of the power lines associated with Beckjord. They will be shutting down U.S. 52 intermittently beginning next Monday October 30<sup>th</sup>. Letter from Duke detailing this and other Beckjord news is posted on the village web-site.

## Personnel & Finance, Paul Vanderbosch:

Paul distributed a summary of the September 2017 financial statements listing each fund and expenditures in the major expense categories.

- At the end of September, the year was about 75% complete. Expenditures for the same nine-month period were about 51% of appropriations.
- Several "funds" have no activity and have no balances. Lynn indicated that she is able to close unneeded funds.
- The village has total debt of \$2.068 million with some payments due through 2051.
- Lynn is looking into the Village's potential liability for unused sick and vacation time for employees: these are terminal benefits that have to be paid when an employee leaves Village employment.

# Lynn Baird, Fiscal Officer:

- Lynn reported that the operating fund balances has been transferred to Park National Bank, paying a 1% interest rate compared to .3% at River Hills Bank.
- There will be first reading about 2017 appropriation changes at the October 24<sup>th</sup> Council meeting.

The 2018 temporary appropriations need to be approved before January 1, 2018.
 The first reading of these appropriations will be November 4<sup>th</sup>; second reading November 28<sup>th</sup>; third reading and approval on December 12<sup>th</sup>.

- Permanent 2018 appropriations need to be approved after January 1 and before March 31, 2018.
- There is \$320,335 in undisbursed funds from the OWDA loan. funds may be drawn on this amount to repay the \$250,000 advanced from the General Fund earlier this year.
- General Fund transfer to Fire/EMS amount to \$175,000 this year, as budgeted.
   The Police Department \$150,000 transfer has not been done.
- A motion is needed to pay bills 614-2017 through 740-2017 and warrants 35958 through 35970 included in the September 2017 financial reports.

• Mike has the following equipment needs:

- Policy book prepared by a third-party firm familiar with police policies: \$4,000 initial cost and ongoing annual cost for updates.
- Blue uniform shirts \$1,200
- Purchase weapons for each officer-right now each one uses his own personal weapon: \$5,500 with holsters.
- o Body cameras, six are needed: \$3,200 and a policy would be required.
- o Six tasers: \$7,000
- The Dodge Charger is on order or soon will be. In addition to the \$23,000 vehicle cost, another \$10,000 will be needed for equipment and installation. Mike is getting quotes from several companies, including one owned by a current officer.

# Village Administrator, Greg Roberts:

 Greg discussed the Knothole situation at the committee meeting; however, it was not discussed at this point during the council meeting since the issue has already been resolved.

Mayor Carr asked Police Chief Couch what is the most important priority on his list.
Chief Couch stated that the policy and procedure package is the priority. Mike will
come back with estimates and meet with Lynn.

# Richard Feldkamp, Safety/Laws/Rules Committee:

Present at the meeting were Ramona Carr, Gary Skeene, Paul Vanderbosch, Dick Feldkamp, Greg Roberts, Chief Vince Bee, and Chief Mike Couch.

# Village Administrator, Greg Roberts:

- Greg recommended the first reading on the structure AT 619 Market Street being condemned.
- The last house on Market Street is being researched for resolution as what can be done with it.
- We need a resolution for the removal of a large Oak Tree at 718 Washington that is ready to fall causing two houses to be damaged.
- Guard rails on 132 at Light Street and at Boyles curve need to be replaced. Bids are being obtained.

# Fire/EMS Chief, Vince BEE:

- Chief Bee advised that this has been Fire Prevention Month and a lot of activity has been done at the schools and other locations.
- The Firefighters FEMA Grant was rejected.
- The department is checking with a grant writer who has had good results, for next year's grant.
- The Quint recently had a problem passing the pump testing.

# Police Chief, Mike Couch:

- Need to get the new Rifles into Policy 301 (use of force procedures and weapons). Mike will send council the revisions.
- The front door and upstairs door at 619 Market Street are standing wide open and something needs to be done about this situation.
- Mike talked about equipping the 2018 police cruiser. Bids are running from \$10,000 to \$12,000 further research is being done.

# Signs at Riverview Subdivision:

 Paul Vanderbosch talked about the 25 mph signs that have been placed in Riverview Subdivision. He feels a few more should be added.

# Mary Allen, Public Works:

## Cemetery Software:

A question arose in another committee Meeting about the cemetery software that had been considered a couple of years ago, a decision has been made to us the UAN

component and not purchase a stand-alone cemetery management package. UAN is software that is provided by the state, many municipalities use it for both accounting and financial recordkeeping and cemetery records. We saved around \$5,000 by using the state provided UAN component. UAN doesn't allow for remote use, but meets our current needs.

#### Road Salt:

In anticipation of inclement weather in the upcoming months, the Village Administrator was asked about road salt. We have some left over from last year and he has a quote form Morton, which we'll use if we need to order more.

## Road Maintenance:

Greg is currently working Brandstetter and Carroll to develop a more comprehensive road maintenance schedule.

# Riverfront Project:

Greg continues to explore and seek bids on this work. The Committee believes KZF has done quality work and would still like to work with them, if their bid is competitive.

## Mary Allen, Economic Development:

# Tiny House Construction and Potential us within the Village:

Members met with Mike at Kasita Homes to understand some of the market trends and how they produce Tiny Homes in Texas. This was an information seeking meeting to help us better understand if we should continue to consider allowing Tiny Houses with the Village. After the meeting , members present spent time talking about Tiny Houses and their possible use in New Richmond; including potential zoning issues.
