Greg Roberts, Village Administrator:

House Bill 512:

House Bill 512 was passed and signed into law last year. The bill update the Ohio EPA rule affecting public water systems EPA required lead and copper testing. The bill adds specific new testing and monitoring guidelines in addition to the current guidelines. The additional rules and regulations ultimately result in higher costs to the water systems. Loans can be applied for from the drinking water assistance fund to pay for studies and projects to conform to the new EPA requirements.

Sale of Village Property:

The first step is to survey the property in question and have a new parcel or parcels created. Request Council authorization to survey the Village owned Plum Street and Water Street properties adjacent to the "Ice House" property on Front Street and make record of parcel ID numbers with the County Auditor.

There was not a quorum present at the most recent Public Works Committee meeting to discuss the sale of village property.

Richard Feldkamp, Safety/Laws/Rules Committee:

Items discussed at the meeting were as follows.

- New statewide golf cart laws. Golf carts are permitted on streets with lower speed limits. They are not permitted on highways. Golf carts are now required to have windshields.
- Landslide on Short Hill. the area has been inspected by an engineer and he recommended waiting for the weather to clear and the ground has had time to dry. Greg mentioned the possibility of placing a tile in the ditch to avoid a storm water stoppage or overflow. Due to the nature of the slide the property owner will not be responsible.
- The water issue on Mr. Walriven's property. Due to the location of the water issue it is not the responsibility of the village.
- Newspaper article regarding Washington Court House new program. Mr. Vanderbosch has spoken to the prosecutor's office regarding this program. The prosecutor stated that they will be working with local police regarding this subject.
- The end of Scott Brown's probation

If Mr. Walriven can find the source/reason for the water issue and prove that it is the village's responsibility then the village will reconsider the situation. Mr. Walriven stated that he has had it looked at by a plumber and the plumber stated that his lines are not leaking and the issue seems to be coming from High Street. The retaining wall is on village property and the village is responsible for it. Mr. Walriven asked for clarification regarding the construction of the retaining wall and whether Rich Riebel was involved in the construction. Greg stated that the village constructed the wall not Rich Riebel. The wall has moved and needs to be fixed. Further discussion included suggestions for Mr. Walriven involving the water issue.
