<u>Chronic Nuisances</u>: An ordinance from the Village of Cleves, Ohio that addresses properties that require repetitive police attention as a result of criminal activity was presented at the last Safety, Laws and Rules Committee. A similar ordinance is anticipated to be presented for 1st reading at the next Council meeting.

<u>Local Government Fund Distribution</u>: The Clermont County Township Association has proposed a new formula for distributing the state local government fund. The net effect of the new "more equitable" formula would result in a loss of over \$50,000. income annually to the Village.
