#### Visitors:

Hannah Lubbers - Clermont County Office of Environmental Quality/Adams-Clermont Solid Waste District:

Hannah spoke about the proposed Adams-Clermont Solid Waste District Management Plan for the years 2018 to 2037. She explained the District is required to revise the Plan every 5 years and get it ratified by townships and municipalities representing 60% of the population of the District, as well as the largest municipality and County Commissioners in each county. There is a 90 day period to approve the Plan, otherwise Ohio EPA may develop the Plan for our district; the District needs a certified copy of the Village of New Richmond's legislation approving the Plan by June 14th, 2019.

In addition to existing programs including emergency debris management and road side trash pick-up, the Adams-Clermont Solid Waste District would like to see an in-school recycling assistance program, multi-family housing recycling assistance and a large-item collection site established. Currently the District's

programs are funded with a \$3/ton generation fee but, with expenses exceeding income and the projected depletion of the reserve fund in several years, the Plan proposes increasing the generation fee to \$3.50/ton in 2020 and to \$4.00/ton in 2021 if expenses continue to rise and exceed income. Increasing the generation fee to \$3.50/ton equates approximately to an additional six (6) cents per household per month.
