# Safety, Laws & Rules Committee report from meeting held 10-07-2019

Administrator Greg Roberts reported (1) the Susanna Way project should soon be underway and (2) the Planning Commission approved the idea of creating a designated outdoor refreshment area bound by Front St. to Willow St. and Sycamore to Augusta streets. A designed refreshment area requires 4 liquor permits; in the Village these are: Green Kayak, Front Street Café, Skippers and the VFW.

<u>Councilmember Feldkamp</u> suggested the speed limit on Bethel New Richmond Rd., from the school to out past St. Peter Church, be lowered from 35 mph to 25 mph.
