#### **ADMINISTRATIVE REPORTS**

#### Village Administrator Greg Roberts

Liberty Landing Park and the Showboat Majestic: The Village's historic waterfront during the steamboat era was the location of a wharf boat – basically a barge that served as a bridge to the public landing for passengers and freight to be unloaded. It was also the site where many people from south of the Ohio River, both free and enslaved, first stepped foot on free soil. In 2002 our Waterfront was recognized by the National Park Service as a documented Underground Railroad site. For over 5 years the village has sought State Capital funding for a project to transform our historic waterfront into Liberty Landing Park, incorporating easier to maintain terraces, a hike/bike trail, and infrastructure to accommodate excursion boats from B&B Riverboats to the Delta and American Queens. In December of 2020, the State allocated \$25,000 for planning and design of Liberty Landing.

In February of this year Council approved a license agreement with the private owner of the *Showboat Majestic*. The Majestic is basically a barge outfitted with the last theatre of its kind within that barge. It is not just recognized as historic; it IS a NATIONAL HISTORIC LANDMARK.

All Village expenditures to date have been put towards bringing needed infrastructure for the future needs of Liberty Landing Park. The current and future licensee's and or transient excursion boats will be afforded access to that infrastructure at their expense.

• River View Bluffs – The Council's Public Hearing of the PUD Application and Preliminary Development Plan was concluded. Ordinance 2021-14 is being presented tonight for first reading. Council has the option of voting on the ordinance tonight, by waiving the 3-reading rule or at the August 10<sup>th</sup> Council meeting, to meet the 15 day between public hearing and vote as in the village Zoning regulations.

- Taco Bell Most are aware by now that the new/old Frisch's building is gone. Architecture and engineering representatives for Taco Bell have been in communication with the Village and County securing permits for the construction of a new Taco Bell restaurant. (Conceptual drawings of the proposed restaurant were attached to his report)
- <u>Bandstand</u> Thank you to Renaissance New Richmond (RNR) and Ed Horgan for the repairs of the cupola. The repairs were paid out of RNR's funds. The cost was just under \$900.

#### Councilman Prues

- People need to come to the appropriate person who can answer their questions rather than rely on Facebook for information.
- The stormwater drainpipe at Front Street needed replacing for several years. Fixing it afforded the opportunity to put needed infrastructure to the future Liberty Landing Park.

# **Police Chief Mike Couch**

• Chief read his response to the public and to the recent comments made on the Friends of New Richmond Facebook page:

"It would not be prudent, responsible, or safe for the Chief of Police to discuss internal operational components of the New Richmond Police Department on a public website or forum.

I can say however, that due to the departure of a seasoned and experienced night shift officer, I made the administrative decision to move Officer Frasure to night shift where his experience, knowledge and community-oriented policing skills are most needed.

This was my decision and was made in the best interest of community safety! We MUST have an experienced officer on duty throughout the overnight hours.

ALL MEMBERS of the NRPD participate in community-oriented policing initiatives and enjoy interacting with ALL MEMBERS of the village community at all levels!

My staff and I do so daily; my trunk contain toys, cars and dog bones that I personally distribute."

• He was informed of the yellow curbs in front of the United States Postal Service mailboxes in Regatta subdivision. Can the PD enforce the law of people parking too close to Stop signs?

Chief Couch: 30' is the state law for parking too close to the stop signs. Beyond this, unless the Village passes an ordinance he has nothing to enforce.

- He is still working to fill the open full-time police officer position. The one applicant left is currently employed part-time with the Village.
- He gave statistics for the month-to-date.
- He commented that Jeannie Farrell said she appreciates all the work that was done in trying to find her son, Bobby Farrell. The primary suspect is in jail. It is heart wrenching for anyone to lose a child. A significant amount of technology allowed them to find the missing person.
- He asked if there were any questions from the public and there were none.

• Everything at the departments is going well. He thanked everyone for their continued support, it is greatly appreciated.

Mayor Ewing: The purpose of this hearing is to receive public input on Sunesis Construction's application for rezoning of parcel# 260923.165 in River View Bluffs Subdivision from R-2 SINGLE FAMILY to PLANNED UNIT DEVELOPMENT (P.U.D.) and APPROVING a PRELIMINARY DEVELOPMENT PLAN.

Council has received confirmation at their July1st, 2021 meeting the New Richmond Planning Commission unanimously recommended approval of the P.U.D. application and Preliminary Development Plan by Sunesis Construction for River View Bluffs with two conditions: 1) any cemetery plot findings will be thoroughly investigated and dealt with in a proper fashion. 2) any future development of Lot 191 would need to be approved by the Planning Commission before moving forward.

Mayor Ewing then invited Ryan Taggert, representative of the developer to start the hearing with an overview of the plan and what is being requested?

#### **Ryan Taggert:**

Mr. Taggert explained

- 1) the property is an extension of the current River View Bluffs
- 2) The opening into this section will begin where River Valley Boulevard dead-ends just beyond Compass Court.
- 3) The purpose of the variance is to change from R2/R3 to PUD to allow for smaller lot sizes. There will be 48 homes on 28.7 acres.
- 4) The homes will be single family homes

- 5) A few minor changes have been made since the original application
- 6) He has been working with the Planning Commission and neighbors concerning a reported cemetery on the property. He personally has walked the property with others and has found no sign of any graves or a cemetery.
- 7) Lot 191 is mainly a hillside. There are no plans on building on this lot. There will be added a deed restriction where any owner of Lot 191 will need to go before the New Richmond Planning Commission before anything can be developed on this lot.

Mayor Ewing opened the public portion, the following are the results of questions and answers.

<u>Councilwoman Ploucha</u> stated 20 years ago she was on the property in question and saw a cemetery with headstones and a possible fence. She inquired as to the remedy if a cemetery would be found.

Mr. Taggert – It depends on the location of the find. If the location is on a building lot the lot will be deemed unbuildable and will be protected as a cemetery. If the location is in a planned roadway he would look into relocation efforts.

<u>James Klug</u> – Asked if there would be any multi-family homes.

Mr. Taggert – There will not be any multi-family homes or attached units.

James Klug – Asked why the zone change was needed.

Mr. Taggert – The lots are smaller than the Village's R2/R3 Zoning allows.

<u>Chris Miller</u> – Asked how much land there would be between Compass Court and the new development.

Mr. Taggert – For the building lots he will clear the building pad. There will be trees between the old and the new lots.

<u>Stacy Dunsmore</u> – Asked when construction is expected to begin.

Mr. Taggert – The plan is to start this fall or spring with the utilities in the winter and asphalt in the spring. Worse case scenario would be April/May. It depends on the weather and how soon the permits are received.

<u>Chris Miller</u> – Asked who would clean the streets during construction.

Mr. Taggert – There will be a street sweeper there at all times and can be used every day during construction if needed.

Councilwoman Ploucha – Asked if the twelve acres (Lot 191) attached to 12 Mile Creek, could be attached to the creek bottom and the ten acres on the other side.

Mr. Taggert – There are no plans to develop that area. He has spoken to several groups such as Clermont County Park District and not-for-profit conservation groups but so far there appears to be no interest. There is another area off Compass Court that might be considered in the future.

There being no additional questions or comments, Mayor Ewing requested a motion to close the Public Hearing.

Councilwoman Allen motioned to close the hearing at 6:15pm; seconded by Councilman Prues.
