<u>Personnel & Finance Committee Report</u> from the meeting held Monday, 08-09-2021 as reported by Councilwoman/Vice Mayor/Committee Chair Allen:

- Before giving the Personnel and Finance report Councilwoman Allen commented that because of some negative feedback received by multiple people related to the July 13, 2021 Council Meeting minutes- specific to information in the Personnel & Finance Section, she has made a few changes to both her notes and provided Clerk of Council Kathy Fuchs new wording to be used in place of the wording previously entered. While what Clerk of Council Fuchs entered was not incorrect, it was misinterpreted by a number of people.
 - Background: Both Chief Couch and Chief Bee noticed there were people on the payroll records who were no longer employees.
 Some had given resignations and others were just no longer available as auxiliary and/or pay-per-call employees.
 - A motion was made, properly seconded, and voted on to accept the names of the individuals who were in the Personnel & Finance table.
 - The negative comments were primarily related to the use of the word "terminate".
 - (M3*) Councilwoman Allen commented she modified the Personnel & Finance meeting notes and made a motion to ask the Clerk of Council to replace what is in the record of proceedings, July 13, 2021 meeting notes with the "New wording to replace the old wording" listed below.
 - Wording in the minutes Council accepted on 7/13/2021: (****) Both Chief Couch and Chief Bee asked the following employees to be terminated from Village records because they left some time ago, but without formal resignation to finalize removing them from the Village payroll: (The paragraph was followed with the table listing the individuals.)
 - New wording to replace the old wording: (****) Both Chief Couch and Chief Bee have identified multiple employees who have resigned or who have advised they are no longer available to work for the department. Resignations have been accepted, but the payroll records need to be updated and their names removed. This is a clerical housekeeping task. The individuals to be removed from our payroll records are in the Payroll Clean Up Table

- (M4*) The Personnel & Finance Committee reviewed all checks and electronic payments for the month of July 2021; we need a motion to pay these bills.
- The Village has not received all of the property tax revenue for the second half of 2021; but it does appear we are where we expected.
- The local tax could be \$20,000 over budget.
- American Rescue Plan (ARP) there is still no date as to when the funds will be received. Acknowledgement has been received and all the required papers have been signed. We anticipate \$280,000 over 2 years. 140,000 each year.
- There are general categories the money can be used for:
 - o Response to public health emergency
 - o Essential employee premium
 - o Revenue loss
 - o Investments in water, sewer, broadband
- **Utility Funds**
 - There have been many repairs and very high expenses this year, causing needed appropriation changes in both accounts
 - 2021 Revenue should exceed budget in all Utility Funds. We need to look very closely at 2022 budgeted expenses and repairs.

Police Chief Mike Couch:

- Two personnel changes
 - \circ (M5*) He received two applications for the open full-time position. Only one applicant has passed through the hiring process. He would like to make a conditional offer to Joshua Fullbeck, who is currently working in a part-time capacity for NRPD. If approved he will move from part-time to full-time pending a medical exam and background checks, at a pay rate of \$17.00 an hour on a oneyear probation.
 - Jason Spradlin, will be sworn in on August 10, 2021, as a nonpaid, auxiliary officer. Mary commented that no motion will be
- The River Days Festival was a success, with only minor police interactions.
- There were multiple questions asked by resident Mickie Vieregge during the July 27th, 2021Council meeting and during s follow-up meeting with Mayor Ewing and Councilwoman Allen, on August 3, 2021. Her questions and answers from Chief Couch are as follows:
 - 1. Question 1 was about the Police Night Out and if the New Richmond Police Department would be doing it this year. Chief said New Richmond does theirs in conjunction with the Fire/EMS Safety Weeks. Chief Bee said the timing would be in October.
 - 2. Question 2 was about having a dog demo. Chief Couch stated it was planned for the Police Night Out/Safety Meeting. It would be an "open sniff" demo.

- 3. Question 3 was in regard to who the New Richmond Police Department's Field Training Officer is.

 Chief Couch and Sgt Mallott provide that training. Chief Couch stated that Ohio does not require a Field Training Officer.
- 4. Question 4 was related to the department having 8 cruisers. Chief Couch stated the two older cruisers are ready to be decommissioned. We have two take home vehicles, the chief's and Sgt Mallott's. The other 4 are used by our officers. We don't run our cars 24/7.
- 5. Question 5 was related to idle cars running in front of the Village Hall, when the officers have gone inside the building.

 Chief Couch said he has instructed his officers not to do this unless they're running in the building for a very short period of time. The dog vehicle does run when the dog is inside.

Fire/EMS Chief Vince Bee:

- Two personnel changes, both have a date of hire of August 11, 2021. They will serve a one-year probation per Village Policy and procedures.
 - (M6*) Hire Jim Lunsford for the position of part-time FF/Paramedic at the rate of \$13.65 hourly.
 - o (M7*) Hire Tyler Eccard for the position of part-time FF/EMT Basic at the hourly rate of \$12.60 hourly.

- TIF (Tax Increment Financing)
 - Allen Freeman mentioned a TIF that would be placed on a property that would not go into effect until a developer is found with a project for that property. Can Council get approval for this type of TIF?
 - The T Box property is for sale. Lance Sizemore is still interested in moving forward in developing the property without Village financing.
 - Village Council has already approved the Ballfield and T-Box properties as developable for a TIF. When a project becomes ready the Village will work with the New Richmond Exempted School District Board and move forward with the TIF as we have with other developments in the Village.
- Vacant Property Ordinance: Administrator Roberts will present Council with a draft ordinance.
- Dog Park Mitigated property at Willow and Market Street approximately 2 acres.
- Complete Streets ODOT culverts may need to be replaced as part of the project which may require additional funding.

Sales have slowed somewhat due to seasonal trends in the real estate market, price increases, and, at least here in New Richmond, the current principal builder, Ryan Homes, is in "catch-up" mode with new homes construction. A second builder should be starting soon in River View Bluffs.

Richard Feldkamp – Received a complaint from an ex-resident in reference to the need to paint the curbs yellow at Walnut/Front Streets, and Union/Front Streets to symbolize "No Parking". He took pictures of a car parked too close to the corner. A discussion ensued over the Village-wide need to correctly mark the intersections for parking with the following points being made:

- Consistency with all markings per Ohio Code.
- The size of emergency vehicles and the space needed to maneuver corners during emergency runs, especially the Quint.
- Handicap Parking
- Once painted, and obvious, the Police Department will better be able to enforce parking laws.
- Outcry of reports of not enough parking on Front Street
- Safety comes first
- When one person parks wrong others follow suit.
- Tow Away Zones are effective
- Start with warning flyers stating they are parking in a NO Parking area since these areas may have had little to no yellow marking for a while
- Businesses have warned patrons to not park incorrectly
- Police Parking signs need to be bigger, possible stenciling also.
- The white arrows on Susanna Way have been very effective
- Open new areas for parking
- Contract with a valet parking service or a shuttle

Comments from audience/Visitors wishing to address Council:

David Vornholt gave a history on how many dams there have been in the 982 miles of the Ohio River between Pittsburgh and Cairo (54 dams) and how deep the river is here at New Richmond on the Ohio (12' – 22')
