Rules councilmembers have agreed to meet on the Monday before the second Council meeting in October which will be October 25, 2021.

Police Chief Mike Couch:

- <u>No personnel change.</u> Jason Fullbeck is closer to fulfilling the requirements for the full-time position.
- Body cameras:
 - o In researching grants Chief Couch has discovered a grant that will cost the Village \$7,500 per year for 5 years.
 - Currently the police department spends \$11,000 for Sgt. Mallott to download the information from the current cameras as well as other administrative tasks. He would much rather have Jason and Patriot on the road than in the office working with the old cameras to get them to upload.
 - Chief Couch currently has in the police department funds \$20,000 from new home permit fees that could be used towards the department's portion of \$45,000 of this matching grant.
 - o NOTE: The Personnel & Finance Committee members are in agreement with using the new home permit fees for the cameras and are recommending this proposal to Council.
- (*M3) Mayor's court costs: Clermont County Municipal Court has raised their court fees from \$85 to \$100. Chief Couch is requesting a Mayor's court cost increase also from \$85 to \$100 to stay aligned.

Fire/EMS Chief Vince Bee:

- Recommends the following personnel changes:
 - (*M4) The reclassification of Joshua Hughes, per his emailed written request, from full-time to part-time Firefighter/Paramedic at the reduced part-time pay rate of \$13.65, effective 9-17-2021, and continuing with his current one-year probation.
 - (*M5) The hiring of Craig (CT) Schoch to fill the now open full-time Firefighter/Paramedic (FF/P) position left by the reclassification of Joshua Hughes. Due to FF/P Schoch fulfilling his two-weeks' notice at his current job, Chief Bee is requesting tonight that FF/P Schoch be hired tonight as part-time FF/P at the part-time rate of \$13.65 effective 9-14-2021, on a one-year probation. During this time, he will begin his orientation period. Once he is available to work full-time Chief Bee will request FF/P Schoch be reclassified to the open full-time position which is expected to happen around September 28.
 - (*M6) The hiring of Cassie Kelley to the position of Pay-Per-Call EMT, at the Pay-Per-Call pay rate, effective 9-14-2021, on a oneyear probation.

- The Village has received approximately \$20,000 in new tap fees from the RV parks. He suggested Council review the Ordinance related to tap fees as an incentive, and discuss how we want to proceed with the known and anticipated new development in the Village
- The Village has an RFP (Request for Proposal) for the Knothole Fields and are circulating for bids
- The capital budget proposal for the Liberty Landing, terrace of the river front, is due November 1, 2021.
- The Village has done zero paving of the streets in the last two years. As a result, some streets are in significant need of repair.
- There was a sewer stoppage issue on Labor Day weekend with roots growing into the sewer lines. We need to use a camera to understand the condition of the major sewer lines. Since there is suspicion of more issues this information would be used to prioritize and determine timing of corrective changes. This may be a project that qualifies for the American Rescue Plan money.
