Personnel & Finance Committee Report from the meeting held Monday, 11-8-2021 as reported by Committee Chair Mary Allen:

November 9, 2021 Personnel & Finance Committee Meeting Summary

Meeting.

The meeting started at 4:35 p.m. and ended at 5:15 p.m.

Discussion Topics:

- 1. There were discussions in the normal four broad areas: Finance, Village Administration, Police Department, and the Fire & EMS Department.
- 2. Before we had the updates from the Department Heads, there was discussion about bonuses for the employees. Lynn provided guidance on how we could use the American Rescue Plan money to reimburse the Village.
- 3. Extensive discussion followed to ensure everyone was aligned to decisions that had been made and were reflected in the spreadsheets. Mary was going to copy all the information into one master spreadsheet and send it out to all the Department Heads prior to the Council Meeting for any last-minute corrections or changes.
- 4. (*M-2) Motion: Motion to reimburse the Village of New Richmond \$57,976 from the American Rescue Funds for lost revenue in 2020.
- 5. (*M-3) Motion: Motion for Council to authorize bonuses for Village employees in the amount of \$46,625, as determined by the Department Heads, in an amount not to exceed \$1,600 per person, to be effective before December 31, 2021.

Finance Committee - Lynn Baird, Fiscal Officer

- 1. We had a high-level discussion on the temporary Appropriations for 2022. Planned budget needs should be given to Lynn asap. This includes:
 - Any anticipated equipment or vehicle purchases, maintenance, repairs for 2022
 - Any expected grants or grant matches fore 2022
- 2. Lynn stated there will need to be appropriation changes:
 - The normal end of the year changes
 - A change for the anticipated bonuses
- Councilwoman Allen reminded all Department Heads to be working on their recommendations related to staffing levels for each department and competitive wage information for all levels. She would like to have this work completed and available to Council by the end of December.
