## **CALL OF MEMBERS:**

Larry Prues – Questions on the streetlamp/decorative lights on Front Street. We used Scott Green for another project, we have a parts list, we need to try to get those lights working. Councilperson Feldkamp checked on lights at Vesper Park, there are 13 fixtures and the globes do not fit base. Also need to be changed to LED. Poles are good. Bob Lindhorst and Councilperson Prues met with and Scott Green and scope of work 30K.

On Water Cooler to be bought right out and no lease agreement. Met a couple from Bethel, they love NR and want to move here. Offered mayor and Glen house as a joke.

#### Dennis Dalton -

Asked about appraisal – this is week 4.

Richard Feldkamp - Nothing to report

#### Ryan Woodruff -

- Resident complaint about basketball hoop on Caroline. Interim Police Chief Mallott sent someone over and sent duty officer and it was taken care of in a timely manner.
- Sent Copies of vacancy ordinances. Township and Village and Ohio does something similar. Type Ohio Vacancy Ord. removed blighted property and stimulated economic growth. Have a discussion later.
- Reached out Public Officials about ARP Funding, what they are doing. See what they are
  utilizing it for. Councilperson Dalton mentioned Diane brought his attention to this.
  Councilperson Prues stated we had \$280K altogether, 225K remaining left, mentioned
  putting in general fund.
- Working on getting a school resource officer with Interim Chief Mallott with our NRPD, this is final year of current contract. Mallott is looking at other contracts and we will be working on it. We can re-negotiate in 2 years.
- Additional parking VFW Mitigated property Councilperson Prues wants to get a
  process. Is there a plan? Clear lot and gravel it and light it. Would fit maybe 40-50 cars.
  Mention of getting Solar Poles as they are inexpensive.
- What do we with the Lamps at Vesper Park? We purchased from Felicity. We can auction off, destroy, maybe put on Craigslist.
- Water and Plum Street questions: What is the concern to vacate property? Dobbins mows Plum St. Water Street is 40 feet out. With Liberty Landing, Water Street could be used as a walking area. If we vacate a street, we need to have an ordinance. Mike Dobbins was going to develop that, nothing has materialized. Councilperson Allen suggested we lease agreement for \$1 a year, can do whatever with it but not sell it. We could put a walking trail behind Landing/Sunset. What about river. Councilperson Woodruff asked what legally we would have to do connect Hausermann towards Water Street. Liberty Landing Engineers can work on it. Councilperson Prues stated it was no value to village and Mike Dobbins does not want to pay for it. Why vacate. Councilperson Feldkamp asked everyone to look at tax map of his property. Former Icehouse is to be tore down. What happens to village if it stays a green space...does it hurt or benefit? Councilperson Prues stated he makes commitments and does not follow thru. He is known to take advantage of taxpayers' money. Councilperson Woodruff is looking into trying to find a way to prevent people on his property. We have paper streets we do not take care of; we have real streets we cannot take care of. Councilperson Prues wants the map set up for everyone to see. Give Mike Dobbins a timeline. Councilperson Allen stated Alleys and Streets just sitting there. Councilperson Feldkamp stated the property was not appraised
- Have we heard anything from Mr. Brumley? 10/25 is after 90 days. Need to have a plan. What are options if boat is still there. We need to start thinking about impounding the Majestic and what the cost will be. He is on the hook for all cost. He lives in Adams County. Councilperson Allen said we do not want to damage the boat as it is historic. Scott Sollmann is checking on a specialty service for this. How do we access property?

#### Mary Allen -

- Met with Interim Police Chief Mallott along with Councilperson Prues, following up on safety cameras, talked to Dorian - our rep that is no longer at Gatso, we are still under contract – we need submit a breach of contract as we have not been able to use it. Supreme Court ruling must be mobile cameras. Interim Police Chief Mallott is checking with Paul Kamphaus to see what the process is. Councilperson Dalton gave statistics on the speed cameras.
- Discussed the Proposed salary structure that everyone received. Scenario 2 seems to be something we could use. At some point will need Executive Session. Could go into effect Jan 1, 2023.

Jon Tharpe: Nothing to report

- Commissioner David Painter: Make sure that we have access to money from Ohio One Agreement is about the Opiate Settlement. 15% Attorney General, 30% municipalities, 55% placed in Ohio Foundation fund. Ready for settlement, perquisites that allows us to get paid. Stele agreement in place which we do. Have not submitted foundation agreement, passed out 2 resolutions. Scott Sollmann thanked him for bringing this to our attention.
- Happening week of Veterans Day: Operation Green Light, will request that all county buildings, residence, businesses "light up" with green light - this will highlight awareness and the services Veterans can receive.
