Andrew Gephardt: Zoning Officer:

- Andrew has been conducting post-flood inspections of properties in the Village directly affected by flood waters.
- Two properties sustained damages greater than 50% of their replacement costs. A
 decision must be taken about he eventual disposition of each property.

Vince Bee, Fire/EMS Chief:

- As a result of the department's response to the fire at the ODOT depot on Old 52, the following equipment was destroyed: 7 complete firefighter outfits (bunker gear), 5 air packs, 8 sections of 2 ½ inch hose, 6 sections of 1 ¾ inch hose, two electrical cord reels and the electrical cords. It was a very difficult fire to control and the cause is still under investigation by the State Fire Marshall.
- Vince complimented all personnel involved in the flood event for the great jobs each performed. Special thanks to Howard Kuehnell our former Zoning Inspector for volunteering his help.

- Mike announced that Officer John Karl has accepted a position with the villa Hills Kentucky Police Department and will be leaving on or about April 7th.

Discussion/Comments:

- We need to have an event to recognize our Fire/EMS, Police, other Village Employees, and organizations who helped the residents in their personal recovery and the Village, as a whole.
- In addition to recognize those who helped with the flood recovery, we should put a positive spin on the recent flooding. Communities have tornadoes and they rebuild. We have floods occasionally and we clean up.
- Flooding is our brand, whether we like it or not.
- The River is beautiful, and we want people to think of New Richmond as a good, small town community, not as a community that has devastating floods (although flooding is always a reality)
- Showcase the river, NR businesses, and our history
