Visitors:

David Vornholt, 310 Susanna Way and NROBA:

Mr. Vornholt spoke regarding positive aspects of the Village. He reported that the Business Association supports the use of speed cameras. He also spoke about several accidents that have happened along 52. He stated that he feels the cameras will make the town safer.

Todd Wuerdeman, 300 Susanna Way:

Mr. Wuerdeman spoke positively regarding the speed cameras. He hopes that the mobile camera will help with safety throughout the village.

Tom Wulker, 401 Washington:

Mr. Wulker and his wife will be moving to the village soon. Mr. Wulker made some notes regarding speed cameras and distributed his notes and information on legislation in Ohio regarding speed cameras.

Mayor Carr stated that the solicitor has reviewed the proposed contract with the Sensys Gatso Group and she will pass all of Mr. Wulkers information on to the solicitor.

Charlie Scott, Willow Street:

Mr. Scott expressed some concerns regarding the possibility of the village being sued and financial aspects regarding the speed cameras.

Andrew Griffin, Village Resident (did not supply address)

Mr. Griffin stated that he is opposed to the speed cameras. He suggested the village hire additional patrolman to enforce the speed limit, he also stated that he feels the cameras will be bad for public relations.

Steve Hack,2110 Beech Cove:

Mr. Hack stated that Beech Cove does not want the village to be known as a speed trap.

Mike Dirr, 1300 Parkers Trace:

Mr. Dirr expressed concerns about the possibility of the speed cameras driving away new business and residents. He also expressed concerns about the cameras causing people to not visit the business district. Some other statements made by Mr. Dirr were as follows

- He thinks the officers do a wonderful job.
- Feels citizens should be able to vote on the issue of speed cameras.
- Pointed out areas of concern.
- Would rather the village hire more officers.

Greg Roberts, Village Administrator:

Sewer Plant Upgrade:

A pre-construction meeting was held last Wednesday with he contractor Doll Layman for the sewer plant upgrade. A new splitter box will be installed by this fall resulting in a betterbalanced treatment process.

OPWC Round 32:

Sewer line repair/replacement project at Dye Creek has been put out for bid. Project is financed through a grant from the Ohio Public Works Commission totally \$349,500. Village contribution is \$42,500.

OPWC Round 33:

Proposing legislation this evening (Resolution 2018-08) authorizing an OPWC grant application to repair/replace culvert and washed out headwall as well as stabilize uphill side drainage ditch on Bethel-New Richmond Rd.

Thanks Pierce Twp!:

Pierce Twp. Public Services Department provided a boom mower and operator today to cut back vegetation on Short-Hill. Our Street Department will clean-up the debris tomorrow. Pierce did a fantastic job. It is an example of the quality of work that can be done with the right equipment.
