**Joe Vogel, Resident and owner of Skipper’s Marina:** Joe provided the following 2019 projected improvements to Skipper’s Marina:

- Replace all cables securing the Marina
- Foam the docks to aid in staying afloat
- Finish remodel on the interior
- Finish remodeling the new patio facility and painting the exterior
- Purchase new kitchen appliances
- General spring painting of the docks (river permitting)

Joe relayed overall 2018 has been a good year, in spite of the high water Skipper's experienced around Memorial Day and the week after Labor Day. Joe has received a lot of positive feedback in regard to the new patio facility acquired from Mike Fink's.

### **Administrative Reports**

#### **Village Administrator, Greg Roberts:**

Veterans Day: The Parade on Sunday went well. At a program yesterday at New Richmond High School, Representative Doug Green announced that U.S. 52 through Clermont County from the Hamilton County to Brown County line has been named the Viet Nam Veterans Memorial Highway.

Signs: "Traffic Laws Photo Enforced" signs are up at entrances to the village.

Beckjord Update: CLP, current owners of the Beckjord properties and their contractors continue to mitigate materials (primarily asbestos) inside the plant. They expect to raze the structure by conventional means within two years. They are working closely with Ohio EPA in monitoring ground water and developing a plan to cap and close the ash ponds. CLP is actively seeking commercial development partners for the site.

Regatta & Union Station: HPA Development Group is in the process of applying to the Village for a Planned Unit Development (P.U.D.) for Union Station. Given the relative difficulty in developing the terrain of Regatta vs. Union Station as well as other factors, H.P.A. has decided to develop Union Station ahead of Regatta. The plan is anticipated to include 70 new homes in Union Station. The Regatta plan would be as many as 76 new homes.

Community Dinner A Community Thanksgiving Dinner sponsored by RiverHills Bank will be held this Friday from 6 to 8 pm at the Williams Boys & Girls Club 213 Union Street.

Old Watkin's Hill Cemetery Volunteers from Hanoi's Lost Child Foundation and the VFW Auxiliary working with a consultant have up-righted several fallen stones in Watkins Hill. The volunteers have been trained on techniques to safely re-set stones. They will continue to work on stones in Old Watkins then move on to Samarian Cemetery.

Mary Allen would like to also recognize Charles Polster for the work he's done cleaning the military stones at Samarian Cemetery.

#### **Ad Hoc Economic Development Committee Chairperson, Mary Allen:**

Mary provided the Mayor and Council with the updated "leave behind" brochure.

#### **Interim Police Chief, Mike Couch:**

- The New Richmond Police Department received 501 calls for service; had 8 Incident reports; 7 Crash reports; executed 1 Search Warrant; issued 25 citations; served 24 warrants and filed 19 Offense reports.
- The New Richmond Police Department is working on Lexapol policies.

**Sgt. Mallott:**

- The NRPD obtained search warrants for a residence in the 800 block of Washington St. Marijuana and paraphernalia were found. A stolen vehicle was also recovered.
- The NRPD recovered a significant quantity of synthetic material during a routine traffic stop.
- The NRPD obtained search warrants for a residence on Union St.; indictments should follow.

**Fire/EMS Chief, Vince Bee:**

- The New Richmond Fire/EMS and Monroe Township police department successfully worked together for hours to remove a heavily entrapped person after a bad car accident on Clermontville-Laurel road.
- There have been reports of phone calls where the caller is soliciting funds. The NRPD does not solicit for funds; if you receive a call from the New Richmond Fire Department asking for donations, it is a scam.
