HOLD HARMLESS COVENANT & INDEMNIFICATION CLAUSE

VILLAGE PROPERTY, PARKS OR FACILITY

In consideration of the use of the designated village property, park or facility for the specified date, in the Village of New Richmond, the undersigned hereby releases and forever discharges, acquits, defends, indemnifies, covenants and holds the Village of New Richmond, employees, agents, officers, volunteers, successors, elected and appointed officials, harmless against any and all claims, cause of action, demands, damages, loss of services and all liability for personal injury or property damage of any kind sustained in any manner arising from the use of the Village property, park or facility, cost and expense, including reasonable attorney fees for the defense thereof, arising from the conduct or management of the undersigned's usage, whether verbal or in writing, or from any act of negligence of the undersigned his/her/its agents, employees, volunteers, invites of licensees in or about the designated property, park or facility, and in the event that event holder should obtain public liability insurance against the foregoing occurrences, the Village of New Richmond, employees, agents, officers, volunteers, successors, elected and appointed officials shall be entitled to claim protection under said insurance.

The event holder is being held responsible for the cleaning up and properly disposing of any litter or debris that occurs as a result of the scheduled usage.

I have read the above, and verify its accuracy, and agree to all terms stated. Any misrepresentation in this application or deviation from the final approved specifications and activities described herein may result in the immediate revocation of the approved permit.

RULES AND REGULATIONS FOR THE VILLAGE OF NEW RICHMOND PARKS

1. **RESERVATIONS:** Person reserving a picnic area must be at least 18 years or older. Person signing contract assumes responsibility for their group and condition of the area after group has left the premises. Payments must be received by stated due date or reservations are subject to cancellation. Acceptable methods of payment include cash (in person), check (\$20.00 fee will be charged to all returned checks) and money order. Area is reserved for the exclusive use of the reserving group. Areas may not be opened to the public and collections of fees are prohibited. Park reservations shall conclude no later than 10:00 pm.
2. **REFUNDS & RESCHEDULING:** Reservation fees are refundable if reserving group gives written notice at least 30 days prior to reservation date or area is rebooked by another group. Reservations will not be cancelled until written notice is received. A group may reschedule their date at no charge with 3 days prior notice. If severe inclement weather on the day of the reservation causes picnic area to become unsafe or unusable, the customer may request a refund. The refund request must be within one week after their reservation. Inclement weather includes severe rain, lightning, storms, but does not include temperatures such as too hot or too cold, nor does it include light showers or the appearance of showers. Weather conditions must be verified with a Village employee.
3. **DELIVERIES, DECORATIONS & SIGNS:** Deliveries must be made during period of occupancy with a member of reserving group present. All equipment, containers, etc. must be removed from the premises before final departure. Only tape may be used to affix decorations to shelters or tables, however, all tape must be removed at the end of the event. All signs are prohibited in the park including the entrances.
4. **ELECTRIC & SOUND AMPLIFICATION:** Noise or amplified sound must not disturb or interfere with any other activity outside the reserved area, without written permission from the Director.
5. **ALCOHOLIC BEVERAGES:** Beer, Liquor and Wine are **NOT** permitted on public property by reserving groups. No person shall use, consume or possess with the intention of use or consumption of alcoholic beverages in a public place on park property. No person shall sell or offer for sale any alcoholic beverage in any park. **NOTE:** Alcoholic beverages that are compliant with DORA rules are permitted in the parks within the DORA (Designated Outdoor Refreshment Area) Please see attached rules and DORA map.
6. **CONSERVATION, FIRES & FIREWOOD:** Cutting or chopping of trees, limbs and vegetation, collection of natural materials, and molesting wildlife are strictly prohibited. Fires are permitted in grills or fireplaces only. Please do not burn garbage or any other materials that will emit sparks. Do not leave fire unattended and make sure fire is completely out before leaving the area.
7. **CHECK-OUT & CLEAN UP:** Reserved park areas must be vacated by dark. The reserving group will be held responsible for clean-up and any damage to the area. All garbage must be placed in the provided receptacles and any decorations taken down. Person/Group reserving area will be invoiced for any damages or excessive litter.

8. **PARK DISTRICT BY-LAWS:** All park rules and regulations apply to the area. Village of New Richmond may terminate, upon just cause, any occupancy at any time without a refund.
9. **EMERGENCY:** In case of emergency please dial **911**. Please notify Village Administrator of any difficulties immediately for appropriate action at 513-553-4146 ext. 15.
10. **ANIMALS:** No person shall permit a dog on any park property where a sign is erected prohibiting dogs. In parks where no such sign is posted, no person shall permit a dog on park property unless dog is held by a leash not exceeding twenty feet in length. No one shall allow a dog under his or her control to be upon public property without some device for the removal and containment of such dog's excrement.

DORA

RULES

-  DORA operates daily between noon and 10PM.
-  DORA beverages can only be purchased from participating establishments.
-  Beverages from one DORA establishment cannot be taken into another DORA establishment or special event area which serves alcohol.
-  DORA beverages are not permitted at all retailers and restaurants, please check each individual location before entering.
-  One beverage is permitted per cup per use. No cans, glass bottles, or outside beverages are permitted.
-  You must stay within the DORA boundaries with your beverage. All cups must be disposed of within the DORA boundaries.
-  Must be 21 years or older. Beverages are not permitted in vehicles.
