AN ORDINANCE ESTABLISHING 2017 PAY SCHEDULE FOR THE VILLAGE OF NEW RICHMOND AND REPEALING ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH

Whereas: Pursuant to Ohio Revised Code Section 731.08 the Village seeks to establish a pay schedule for Village employees, officials and officers,

NOW THEREFORE BE IT ORDAINED, by the Council of the Village of New Richmond, State of Ohio at least $\frac{3}{4}$ of the members concurring:

1. That the rates of compensation of various officials, officers and employees of the Village of New Richmond shall be established as represented by attached "Exhibit A".
2. This ordinance shall be applicable to employees of the Village of New Richmond referenced in "Exhibit A" on or after January 1, 2017. Pursuant to Ohio Revised Code Section 9.44 it is herewith declared that the anniversary date of employment is the anniversary date of the most recent hiring as a full or part time employee.
3. All provisions of Ordinances and Resolutions inconsistent with the provisions herein shall be and herewith repealed. Pay rates for employee positions not listed on "Exhibit A" shall remain in full force and effect after January 1, 2017.
4. That Council finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting and that all deliberations of Council which resulted in the passage of this Ordinance were taken in meetings open to the public, in full compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


