**ORDINANCE AMENDING THE 2020 APPROPRIATIONS**

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of New Richmond, Ohio, with a majority of its members concurring:

1. Amends the 2020 appropriations as indicated.

2. Approves the fund transfers and new funds as indicated.
3. That Council finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting and that all deliberations of Council which resulted in the passage of this Ordinance were taken in meetings open to the public, in full compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
4. That the Village by a  $\frac{3}{4}$  majority vote hereby dispenses with the requirement that the Ordinance be read on three separate days and hereby authorizes the adoption of the Ordinance upon its first reading. That this Ordinance shall take effect and be in force from the earliest date allowed by law.
5. That the Council of the Village of New Richmond passes this Ordinance as an emergency, necessary for the preservation of the public peace, health, welfare, and safety of the Village of New Richmond.
