**AN ORDINANCE APPROVING THE WAIVING OF THE RESIDENCY REQUIREMENT FOR DIANE SCHAFER, VILLAGE OF NEW RICHMOND FISCAL OFFICER**

Whereas: Diane Schafer was appointed Fiscal Officer on April 26, 2022, and

Whereas: Village Council has expressed their interest in waiving the residency requirement as permitted in Section \_\_\_\_\_ Ohio Revised Code  
733.262D

NOW, THEREFORE, LET IT BE ORDAINED, by the Council of the Village of New Richmond, State of Ohio, a majority of the members concurring:

1. Approves waiving the residency requirement for Diane Schafer, Village of New Richmond Fiscal Officer.
2. That Council finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting and that all deliberations of Council which resulted in the passage of this Ordinance were taken in meetings open to the public, in full compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
3. That the Village by a  $\frac{3}{4}$  majority vote hereby dispenses with the requirement that the Ordinance be read on three separate days and hereby authorizes the adoption of the Ordinance upon its first reading. That this Ordinance shall take effect and be in force from the earliest date allowed by law.
4. That the Council of the Village of New Richmond passes this Ordinance as an emergency, necessary for the preservation of the public peace, health, welfare, and safety of the Village of New Richmond.

Councilperson \_\_\_\_\_ seconded the motion to adopt the foregoing Ordinance and upon roll call the vote was as follows:




