AN ORDINANCE AUTHORIZING THE FISCAL OFFICER TO TRANSFER MONEY FROM THE SEWER FUND TO THE FOLLOWING DEBT FUNDS: SEWER LINE, WATER FUND TO THE BETHEL NEW RICHMOND SEWER LINE #1, BETHEL NEW RICHMOND SEWER LINE #2, THE SEWER PLANT, THE CONSOLIDATION LOAN AND THE EXPANSION LOAN, REPEALING ALL CONFLICTING ORDINANCES

BE IT ORDAINED, by the council of the Village of New Richmond, Clermont County, Ohio, at least three-fourths of its members concurring:

SECTION 1. That the Fiscal Officer is hereby authorized to transfer up to and NO MORE THAN Seven Thousand Four Hundred Eighty Eight Dollars (\$7,488.00) from the Sewer Fund to the Bethel New Richmond Sewer Line Debt #5721 Fund, Nine Thousand Four Hundred Ninety Seven Dollars (\$9,497.00) from the Sewer Fund to the Bethel New Richmond Sewer Line Debt #5723, Eighty Six Thousand one hundred Ninety Six Dollars (\$86,196.00) from the Sewer Fund to the Sewer Plant Debt Fund # 5724, Three Thousand Eight Hundred Ninety Seven (\$3,897.00) from the Sewer Fund to the Consolidated Debt Fund #5725, Nine Thousand Eight Hundred Thirty Five Dollars (\$9,835.00) from the Sewer Fund to the Sewer Expansion Debt Fund #5726 during the fiscal year ending December 31, 2016.

SECTION 2. All conflicting ordinances or sections thereof are hereby repealed.

SECTION 3. This ordinance shall take effect and be in force from the earliest date allowed by law.
