TRANSFER MONEY FROM THE SEWER FUND TO THE
FOLLOWING DEBT FUNDS:
BETHEL NR SEWER LINE FUND 5721,
BETHEL NR SEWER LINE FUND 5723,
SEWER CONSOLIDATION LOAN FUND 5725,
SEWER LINE EXTENTION FUND 5702
REPEALING ALL CONFLICTING ORDINANCES**

BE IT ORDAINED, by the council of the Village of New Richmond, Clermont County, Ohio, with a majority of its members concurring:

SECTION 1. That the Fiscal Officer is hereby authorized to transfer up to and NO MORE THAN:

Ninety-Five thousand Twenty Dollars and Eighty Seven Cents (\$95,020.87) from the Sewer fund to the Sewer line Extension Fund #5702

Seven Thousand Four Hundred Eighty-Eight Dollars and Twenty-Six Cents (\$7,488.26) from the Sewer Fund to the Bethel New Richmond Sewer Line Debt Fund #5721,

Nine Thousand Four Hundred Ninety-Eight Dollars (\$9,498.00) from the Sewer Fund to the Bethel New Richmond Sewer Line Debt Fund #5723,

Three Thousand Eight Hundred Ninety-Eight (\$3,898.00) from the Sewer Fund to the Consolidated Debt Fund #5725, during the fiscal year ending December 31, 2018.

SECTION 2. All conflicting ordinances or sections thereof are hereby repealed.

SECTION 3. That Council finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting and that all deliberations of Council which resulted in the passage of this Ordinance were taken in meetings open to the public, in full compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. This ordinance shall take effect and be in force from the earliest date allowed by law.
