**A RESOLUTION TO APPOINT THE VILLAGE OF NEW RICHMOND
CLERK OF COUNCIL TO ATTEND PUBLIC RECORDS TRAINING
ON 9\16\16 AS DESIGNEE FOR THE MEMBERS OF VILLAGE
COUNCIL AND DECLARE AN EMERGENCY**

Whereas, All officials elected to statewide or local office are required to receive three hours of certified public record training in order to enhance the officials' knowledge of the duty to provide access to public records as required by § 149.43 of the Ohio Revised Code for each term of office.

Whereas, The officials may appoint an appropriate designee to attend the certified public record training on their behalf pursuant to Ohio Revised Code § 109.43(B).

NOW THEREFORE BE IT RESOLVED, by the Council of the Village of New Richmond, State of Ohio at least a majority of the members concurring:

1. That Council appoints Clerk of Council, Kelly Painter, as an appropriate designee to attend the certified public records training required by Ohio Revised Code § 109.43 on September 16, 2016.
2. That Council finds and determines that all formal actions relative to the passage of this resolution were taken in an open meeting and that all deliberations of Council which resulted in the passage of this Resolution were taken in meetings open to the public, in full compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

3. This action is declared an emergency and passed as such because of the date of the training, necessitating passage as emergency so the Clerk of Council can attend said training.

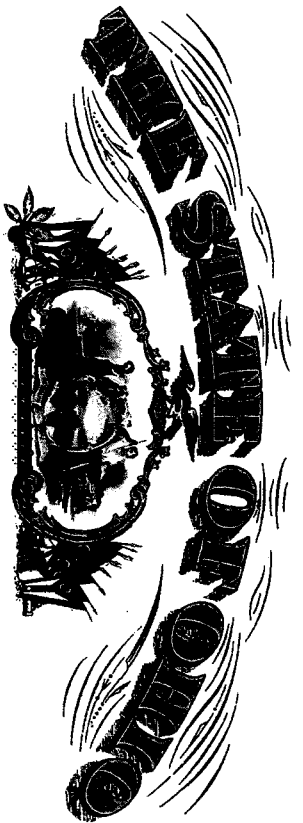


