**CONTRACT AGREEMENT BETWEEN MICHAEL WYLIE AND THE  
VILLAGE OF NEW RICHMOND, OHIO**

The Village of New Richmond is in need of an Administrative Police Chief to fill in for Police Chief Randy Harvey subsequent to his resignation.


Mr. Wylie has agreed to enter into a month-to-month contract with the Village of New Richmond as an Administrative Police Chief for the New Richmond Police Department. This will be at a rate of \$800.00 per week. His services will be in an administrative position only. Mr. Wylie will not be eligible for Police & Fire Pension, sick leave, holiday pay, vacation pay or health insurance benefits.

Mayor Ramona Carr will be the direct supervisor of Mr. Wylie.

This contract will take effect 4/28/2017 and continue on a month-to-month basis until a permanent replacement is established.
