

RESOLUTION 2018 -02

Resolution Authorizing the Village Administrator to submit a Clermont County CDBG FY 2018 Grant Application for the Susanna Way Promenade Project

WHEREAS, the Community Development Block Grant (“CDBG”) program run by the U.S. Department of Housing and Urban Development (“HUD”) is a flexible program that provides communities with resources to address a wide range of unique community development needs; and

WHEREAS, Clermont County is currently accepting applications for their annual CDBG grant program; and

WHEREAS, the Village is in need of funds to create a walkway and install a curb and gutter along the riverside of Susanna Way, and

WHEREAS, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under the CDBG grant program; and

WHEREAS, it is the opinion of Council that creating a walkway and installing a curb and gutter along the riverside of Susanna Way will serve to improve the public peace, health, safety, and welfare of the residents of the Village of New Richmond; and

WHEREAS, the total engineered cost estimate for said project is \$175,000; and

WHEREAS, the Village will request \$157,500 from the Clermont County CDBG Program, and

WHEREAS, the Village will advise the Clermont County CDBG Program, is will commit to paying \$17,500.00 or (10% of the estimated cost) towards the project as a local contribution if the Village’s CDBG grant request is awarded.

NOW, THEREFORE, BE IT RESOLVED, that the Council of the Village of New Richmond, Ohio, with five of its members concurring:


Section 1: Does hereby authorize the Village Administrator to submit a Clermont County CDBG grant application to the Clermont County Board of Commissioners requesting up to \$157,500 in CDBG grant funding that will be designated towards the Susanna Way Promenade Project.

Section 2: Does hereby commit to paying up to \$17,500.00 or (10% of the estimated cost) towards the project as a local contribution *if* the Clermont County CDBG grant request is awarded to the Village for the Susanna Way Promenade Project.


- Section 3. Does hereby authorize the Village Administrator to execute an agreement with the Clermont County Board of Commissioners upon an award of a CDBG grant funding designated towards the Susanna Way Promenade Project.
- Section 4. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Council and any of its committees that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- Section 5. The resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, or welfare of the residents of the Village of New Richmond. That the Village by a majority vote hereby dispenses with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of the Resolution upon its first reading. That this Resolution shall be effective at the earliest date allowed by law.


