RESOLUTION AWARDING THE CONTRACT FOR ASPHALT REPAIRS AND PAVING OF BETHEL-NEW RICHMOND ROAD TO BROWN COUNTY CONSTRUCTION, INC., AND DECLARING AN EMERGENCY

Whereas: The Village of New Richmond desires to make asphalt repairs and paving on Bethel-New Richmond Road and

Whereas: Brown County Construction was the lowest most responsive bidder with the total base bid and alternates in the amount of \$107,309.00, and

<u>Whereas:</u> Brown County Construction has submitted change orders to reduce total costs to fit the Village of New Richmond's 2020 paving budget, and

NOW THEREFORE BE IT RESOLVED by the Council of the Village of New Richmond, State of Ohio a majority of the members concurring:

- 1. That Council awards the asphalt repairs and paving of Bethel-New Richmond Road to Brown County Construction, Inc., and authorizes the Village Administrator to execute a contract attached hereto as Exhibit "A" (and any other necessary documents) with Brown County Construction, Inc. in the amount of \$83,909.00 to complete the required repair and paving of Bethel-New Richmond Road within the Village limits.
- 2. That Council finds and determines that all formal actions relative to the passage of this resolution were taken in an open meeting and that all deliberations of Council which resulted in the passage of this resolution were taken in meetings open to the public, in full compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
- 3. That this action is declared an emergency due to the need to complete a public improvement in a timely manner, considering the seasonal nature of paving and the poor condition of the roadway, thus preserving public health, safety and welfare of the Village and passed as such.
- 4. That the Village by a ¾ majority vote hereby dispenses with the requirement that the Resolution be read on three separate days and hereby authorizes the adoption of the Resolution upon its first reading. That this Resolution shall take effect and be in force from the earliest date allowed by law.


