## VILLAGE OF NEW RICHMOND, OHIO

Council for the Village of New Richmond, Ohio met in regular session this 23<sup>rd</sup> day of February, 2021.

Councilperson Allen moved for adoption of the following:

## A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO APPLY FOR AND EXECUTE AN APPLICATION WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES FOR A PADDLING ENHANCEMENT GRANT AND DECLARING AN EMERGENCY

WHEREAS, the State of Ohio through the Department of Natural Resources Waterways Safety Fund administers financial assistance for public boating access; and

WHEREAS, the Village of New Richmond desires financial reimbursement under the Paddling Enhancement Grant Program.

**NOW, THEREFORE** be it resolved, that New Richmond Village Council, with a majority of its members concurring:

- 1. The Village of New Richmond approves of filing an application for Paddling Enhancement Grant financial assistance.
- 2. Greg Roberts, Village Administrator and Project Manager is hereby authorized and directed to file and execute an application with the Ohio Department of Natural Resources and provide all information and execute all documentation required to be eligible for possible financial assistance.
- The Village of New Richmond agrees that it has and will obligate the funds required to satisfactorily complete the project under the terms and conditions of the Cooperative Agreement if the project is accepted for financial assistance.
- 4. That the Village by a ¾ majority vote hereby dispenses with the requirement that the Resolution be read on three separate days and hereby authorizes the adoption of the Resolution upon its first reading. That this Resolution shall take effect and be in force from the earliest date allowed by law.

5. That Council finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting and that all deliberations of Council which resulted in the passage of this Resolution were taken in meetings open to the public, in full compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
